- 4 The following proof of registration of the Company must be produced before the Council may issue tender documents:
  - (i) **Original Licence/Digital Certificate issued by UPKJ and Valid Certificate Company Registration with Construction Industry Development Board (CIDB) for UPKJ Registered Contractor Works only.**
  - (ii) **Copy of Certificate of UPKJ Licence and Certificate of Company Registration with Construction Industry Development Board (CIDB) shall be submitted.**
