CONTROL ON COVID-19 DURING NATIONAL RECOVERY PLAN PHASE 2 FOR SARAWAK (NRP PHASE 2 SARAWAK)

1. In line with Sarawak Disaster Management Committee and National Security Council (SDMC & MKN) decisions / announcement vide ***SOP Pelan Pemulihan Negara Fasa 2 Negeri Sarawak*** dated 14th July 2021 pertaining to **Sarawak moving on to Phase 2 of the National Recovery Plan (NRP Phase 2 Sarawak)**, Sibu Municipal Council (SMC) wish to seek the close cooperation of the following business sectors / activities which are regulated and licensed by SMC and to **strictly comply with SDMC / MKN requirements in order to operate:**
 - 1.1 **Public Market, Wet Market, Wholesale Market, Tamu, Week-end and Night Market** under the supervision of SMC
(Pasar Awam, Pasar Basah, Pasar Borong, Tamu Kekal, Pasar Minggu dan Pasar Malam di bawah Seliaan PBT)
 - 1.2 All **merchandise stall** (operasi kedai pakaian) at the 1st floor of **Sibu Central Market** and **Grand Height Market**
 - 1.3 **Restaurant, food shop, food stall, food truck, road-side hawker, itinerant hawkers, food court, hawker centre, road-side stall or kiosk** but subject to **Ministry of Local Government and Housing Sarawak (MLGH) SOP**.
(Restoran, Kedai Makan, Gerai Makan, Kenderaan Bersaji (*Food Truck*), Penjaja Tepi Jalan, Penjaja Beredar, Medan Selera, Pusat Penjaja, Gerai Makan Tepi Jalan atau Kiosk (tertakluk kepada SOP yang dikeluarkan oleh MLGH)
 - 1.4 **Laundry** including self-service laundry
(Kedai Dobi, termasuk dobi layan diri)
 - 1.5 **Hair saloon, barber and hair dresser** but limited to **basic hair cut only**
(Kedai Gunting Rambut / Saloon untuk gunting rambut asas sahaja)
2. All operating hours are **from 6 am to 10 pm only** except for those specifically mentioned in the SOP.
3. In view of the **detection of Delta Variant in Sarawak**, **Ministry of Local Government and Housing Sarawak** will review and improve on the

SOP for dine-in at eateries in Phase 2 of the National Recovery Plan in Sarawak. Currently, **dine-in is not allowed** until such new revised guidelines are issued by Ministry of Local Government and Housing Sarawak.

4. The following **businesses are not allowed to operate**:
 - 4.1 **Reflexology & health establishment outlet, spa, beauty saloon, pedicure and manicure**
(Perkhidmatan urut, spa dan refleksologi, wellness, pusat rawatan kecantikan serta perkhidmatan pedicure dan manicure)
 - 4.2 **Cybercafe**
(Kedai cybercafe)
 - 4.3 **All entertainment outlets / activities, such as night club, pub, cinema, karaoke, including family karaoke, performance at hotel lounge, busking**
(Aktiviti di kelab malam, pub, panggung wayang, karaoke termasuk karaoke keluarga, aktiviti persembahan di lounge hotel dan aktiviti indoor atau outdoor busking)
5. The above requirements are based on *SOP Pelan Pemulihan Negara Fasa 2 Negeri Sarawak* dated 14th July 2021. Kindly comply with latest SOP issued from time to time by Sarawak Disaster Management Committee (SDMC), *Majlis Keselamatan Negara* (MKN), *Kementerian Kesihatan Malaysia* (KKM) and Ministry of Local Government and Housing Sarawak (MLGH).
