4 The following proof of registration of the Company must be produced before the Council may issue tender documents:

- (i) *Original Licence issued by UPKJ and*
- (ii) *Valid Certificated Company Registration with Construction Industry Developement Board (CIDB) for UPKJ Registered Contractor Works only*
- (iii) *Copy of Certificate of UPKJ Licence and Certificate of Company Registration with Construction Industry Development Board (CIDB) shall be submitted.*
- (iv) *All tender document must be collected by a Company's Director or Senior Officer with Letter Authorization from the Company and to bring along the Company's Chop.*
